Subject : Common position adopted by the Council with a view to the adoption of a Regulation of the European Parliament and of the Council on the hygiene of foodstuffs

Page 5, recital (16), second sentence

For: "Flexibility is particularly important for regions suffering from special geographical constraints, including the outermost regions referred to in Article 299(2) of the Treaty."

Read: "Flexibility is particularly important for regions that are subject to special geographical constraints, including the outermost regions referred to in Article 299(2) of the Treaty."

Page 24, Article 13(3)

For: "3. Member States may, without compromising the objectives of this Regulation, adopt national measures adapting the requirements laid down in Annex II in accordance with paragraphs 4 to 7 of this Article."

Read: "3. Member States may, without compromising achievement of the objectives of this Regulation, adopt, in accordance with paragraphs 4 to 7 of this Article, national measures adapting the requirements laid down in Annex II."

Page 24, Article 13(4)(a)(ii)

For: "(ii) accommodating the needs of food businesses situated in regions suffering from special geographical constraints."

Read: "(ii) accommodating the needs of food businesses situated in regions that are subject to special geographical constraints."

Page 25, Article 13(6), fourth and fifth sentences

For: "The Commission may decide, in accordance with the procedure referred to in Article 14(2), whether the envisaged measures may be implemented subject, where necessary, to appropriate amendments. Where appropriate, the Commission may propose general measures in accordance with paragraphs 1 or 2."

Read: "The Commission may decide, in accordance with the procedure referred to in Article 14(2), whether the envisaged measures may be implemented, subject, if necessary, to appropriate amendments. Where appropriate, the Commission may propose general measures in accordance with paragraph 1 or 2."

Page 25, Article 13(7)(b)

For: "(b) if, one month after the expiry of the period referred to in paragraph 6, the Commission has not informed Member States that it has received written comments or that it intends to propose the adoption of a decision referred to in subparagraph (a)."

Read: "(b) if, one month after the expiry of the period referred to in paragraph 6, the Commission has not informed Member States that it has received written comments or that it intends to propose the adoption of a decision in accordance with paragraph 6."

Page 28, Article 18

For: "... in the Official Journal of the European Communities."

Read: "... in the Official Journal of the European Union."
