This tool allows us to track how many times reports were accessed and downloaded, when and from which country. It also enables automatic creation of Digital Object Identifiers (DOIs) which makes it possible to track citations of individual reports. We are looking at compatible components to provide additional and more automated analysis.</p>
<p>Action 3 - <b>Performance and Resources Q4 2023-24 (FSA BC 24/06/04)</b></p>	<p>Julie Pierce to provide further information about sampling figures for targeted surveillance showing non-compliance.</p>	<p>9/9/24</p>	<p>Julie Pierce – <b>Complete</b></p> <p>Targeted sampling is for specific commodities for specific hazards to consider emerging risks. Decisions on what to target are intelligence-led and aims to validate that there may be a risk. In 23/24 we tested 1947 samples and found 174 (9%) to be non-complaint. This compares to 14% non-compliance in FY22/23 based on 2585 samples.</p>
