March 2025	<p>Julie Pierce - <b>Closed</b></p> <p>The FSA undertook 2 research projects to determine the cost/impact of food crime and then the NFCU:</p> <ul style="list-style-type: none"> <li>• <b>Cost of Food Crime (CoFC) Phase 1</b> - developed a framework to capture the full range of impacts that food crime has on the UK economy, and assessed the availability of data needed to provide an estimated cost <a href="https://www.food.gov.uk/research/food-crime/the-cost-of-food-crime">https://www.food.gov.uk/research/food-crime/the-cost-of-food-crime</a></li> <li>• <b>CoFC Phase 2</b> - building on the framework developed in Phase 1, a CoFC model was developed. The total cost of food crime on the UK was estimated to be between £410 million and £1.96 billion per year. This is equivalent to between 0.07% and 0.33% of the UK food industry turnover each year. <a href="https://www.food.gov.uk/research/the-cost-of-food-crime-phase-2-project-brief-and-deliverables">https://www.food.gov.uk/research/the-cost-of-food-crime-phase-2-project-brief-and-deliverables</a></li> </ul> <p>Then SERD and NFCU considered options for further developing the research to fine tune the current estimated cost range of food crime. However, we agreed that this should not be prioritised because for it to be meaningful the research would need some more examples of food crime cases that have concluded. We review this every year as we have a broader range of food crime criminals convicted and sentenced to enhance the further research, but it does not score sufficiently highly to be taken forward at this time.</p>
