Consultation subject

This consultation concerned eight (8) GMOs that have been submitted for authorisation in Great Britain (GB). EU legislation relating to regulated products continues to apply in Northern Ireland, under the current terms of the Northern Ireland Protocol (NIP).

Also included in this consultation was an administrative change to the authorisation holder's details for fifty-one (51) authorised GMOs.

In addition to this consultation, we have also published a joint Food Standards Agency (FSA) and Food Standards Scotland (FSS) scientific opinions document, relating to the relevant GMOs. We also welcome comments on these.
