He is an experienced Board Director in the Private and Public Sector. He is a Non-Executive Director for Better2Know Limited; Executive Chair to Wellstate HTA Limited (a Health Technology and Economics Consultancy); a Non-Executive Director and ARAC Chair to the Veterinary Medicines Directorate and is a member of the UK Genetics for Livestock and Equines Committee.

Timothy has served as a Senior Civil Servant in the DHSC and led high profile initiatives including the establishment of the National Institute for Clinical Excellence (NICE), the UK National Screening Committee and several other health policy and service initiatives on clinical standards and cost effectiveness. Over the following 12 years, he was Chief Executive to three NHS Primary Care Trusts and a Member of the UK

Secretary of State for Health's Sounding Board. He led the Greater Manchester Association of Primary Care Trusts and served on the Prime Minister's Futures Forum and co-authored the Forum's report, "The NHS Role in Public Health".

Timothy has a PhD in Molecular Immunology from Kings College, Cambridge University and started his professional life as an Academic Scientist with Research Fellowships at Cambridge and in London.
