

Temporary Operational Instruction

Action note: 2024-08-29 - Chapter 6 of the Manual for Official Controls (MOC) – Review of Bluetongue Virus (BTV) designations in slaughterhouses

Purpose

This action note is to inform operational staff of a new temporary operational instruction regarding the review of designations for the 2024/25 BTV outbreak.

Background

[In preparation for a BTV outbreak, 33 slaughterhouses in England and Wales were predesignated during the last few months. With the recent cases confirmed w/c 26 August 2024, a BTV outbreak has been declared and subsequently the designations issued in season 2023-24 have been revoked and designations re-issued. Defra has asked FSA to carry out a review of all the BTV designations that have been just re-issued for the 2024-2025 season.

Procedure

This review will consist of a plant-based exercise where the establishment's OV will undertake an on-site assessment of the FBO SOPs and structural facilities, using the BTV designation document as baseline.

To facilitate this, the Notifiable Disease portfolio has created a short questionnaire to be completed for each plant by the lead OV. The questionnaire has 5 questions related to the designation procedures and their implementation (see annex 2).

The main purpose of the review is to ensure that the operational procedures have not changed since the initial designation, and that the establishment can receive and handle the animals from the controlled zone adequately to minimise the risk of the disease spreading.

E and J will coordinate the distribution of the questionnaire through the designated abattoirs - https://www.gov.uk/guidance/bluetongue-movement-licences-and-designated-slaughterhouses. Once the review is carried out and the questionnaire is completed by the OV, this will be forwarded to the local Field Operational team (FVL and/or FVC) for a quick sense check (please include Approvals in this exchange), who will be sending this back to the Approvals team for final processing once satisfied that the controls are in place.

Time spent in BVT controls, including designation, can be charged by OVs using "GDIS", and the review of the designations must be completed during normal operating hours. We aim at completing this exercise by Friday the 6th of September 2024 but can adjust if there are time constrains in some establishments. Priority plants are the ones located in the East of England, near the outbreak

Front line staff are required to note the following action

- **OVs** are requested to carry out the review of the BTV designations as soon as possible in liaison with the FBO. Once the check list is completed submit this to their FVC/FVL for clearance, and to approvals team for tracking.
- **FVC/FVLs** should carry out a sense check of the form submitted by the OV, and once satisfied the controls in place are satisfactory, to confirm to the Approvals team.
- **Approvals team** to coordinate and keep track of the process and liaise with Defra and Welsh Government as required.
- **ND portfolio** to provide support to all involved in the process and liaise with Defra and Welsh Government on any BTV related issue.

Note the contents of the action note, ensuring it is read by all front-line staff. Where necessary, print a copy for the plant file.
