Incident Overview:

Recent investigation findings and testing has revealed the presence of peanut traces in certain batches of mustard-containing products. From our investigations thus far, it is likely that the issue is likely based at agricultural levels and therefore no specific timeframe can be applied prior to these detections. Given the serious allergenic nature of peanuts, this poses a potential risk to consumers, particularly those with severe peanut allergies.

Our Indian supplier, from whom we purchased the majority of our mustard, had not recognized that there was a risk of peanut cross contamination from farms and markets they purchased from, and this information was not on the specification document sent. Occasionally we purchased this product from the UK market and were not careful enough in checking specifications for these products. Not all these specifications referenced peanuts, however.

Applying an abundance of caution, due to the severity of some people's reactions to this allergen, FGS Ingredients has taken the decision to withdraw all stock sold up to and including 30th September 2024.

In cases where these ingredients have been directly or indirectly included in retail products, impacted products should also be recalled to ensure consumer safety. These new measures reflect our commitment to the highest standards of food safety and allergen management.

HACCP Allergen Control Improvement

We have identified a gap in our previous system, where precautionary allergen statements were not systematically observed in all cases. This meant that in certain instances, precautionary allergen information from suppliers was not fully relayed to our customer specifications. We have addressed this issue by implementing stricter verification procedures to ensure that all relevant allergen information is properly conveyed. This change ensures that precautionary allergen labels are consistently applied and communicated throughout the distribution process, minimizing the risk to consumers and enhancing overall food safety.

As part of our continuous efforts to strengthen food safety, we have recently enhanced our HACCP systems to scrutinize allergen information for all incoming products. This includes a more rigorous review of precautionary allergen labelling and statements provided by our suppliers, ensuring that any such information is clearly communicated in the onwards distribution of these products to our customers. This improvement is designed to prevent any risk of allergen cross-contamination and ensure full transparency in our supply chain.

Actions Taken by FGS Ingredients:

Allergen Testing: We have implemented additional allergen testing for all mustard-related products before dispatch to ensure safety and compliance.

Updated Labelling: To mitigate the risk of cross-contamination, we are now including a "may contain Tree-nuts and peanuts" statement on all bulk and retail packaging of mustard products where risk assessments indicate it has not been possible to eliminate this risk and this reflects also on our specifications.

By reinforcing these procedures, we aim to minimize the risk of allergen exposure and provide greater transparency, allowing our customers to make informed decisions about the products they receive. This enhancement strengthens our commitment to food safety and allergen control throughout the supply chain.
